

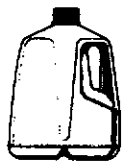

## Recycling Do's and Don'ts

### Curbside Recycling

Remember - Recyclables from Lisbon households are picked up every week - just set your blue bin out at the curb. If you are unsure which day your street receives service call the Town Hall or just check your neighborhood. Recyclables must be out by 6:00 a.m. on your day of service. **Be Sure to:**

- ✓ Tie your paper or place in a grocery bag. **No Loose Paper!**
- ✓ Don't place any recyclables in plastic bags.
- ✓ Leave Bottles and Cans loose in the bottom, place bag of paper on top!
- ✓ Be sure that the recycling bin is out at the curb - [ not half way up the driveway ! ]



### Bottles and Cans

Tin Cans & Metal Food Containers: Rinse cans well, lids may be left attached. Caps from jars and empty aerosol cans may be included.

Glass Food Containers: Food glass bottles only. Remove lids from jars No light bulbs, window panes glass, dishes.

Paper Milk & Juice Cartons: Rinse well and flatten

Plastics Code #1 and #2 only: Please look for the recycling code on the container bottom. Plastic codes other than #1 or #2 are not recycled. Plastic motor oil bottles are not recycled.

- ✓ Transparent jugs #2 (milk)
- ✓ Colored plastics #2 (detergent)
- ✓ Clear PETE #1 bottles (soda, water)



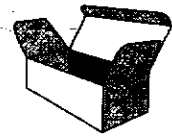

# Newspaper and Cardboard



Newspaper, Magazines, Junk Mail: Newspapers, magazines, catalogs, colored paper, white office paper, computer printouts, envelopes, paper bags, paperback & hard covers books. Tie into bundles, or place in a brown grocery bag for easy handling.

Cardboard Boxes: Cut and Flatten to a size to exceed 2 1/2 feet. Place next to recycling bin. No soiled pizza boxes or oil soaked corrugated!

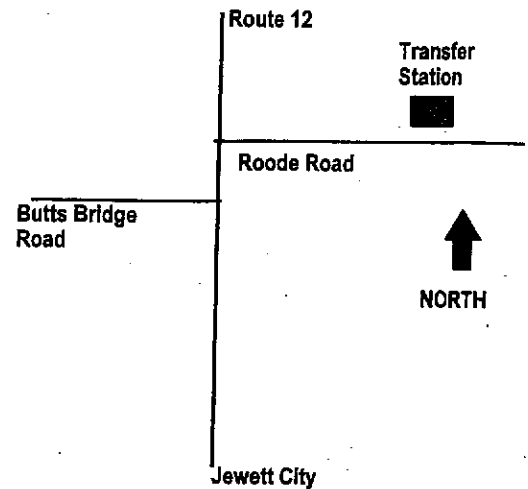

Residents of Lisbon have the option of using the Wheelabrator facility on South Burnham Highway (Route 169). The facility is open from 7:00 a.m. to 5:00 p.m., Monday through Friday. Residents will need to show a valid drivers licence which shows that Lisbon is their town of residence.

“Municipal Solid Waste” means solid waste from residential, commercial & industrial sources, excluding solid waste consisting of significant quantities of hazardous waste as defined in section 22a-115, land-clearing debris, demolition debris, biochemical waste, sludge & scrap metal. CGS 22a-207(23)
