# 6. Reports -

a. Chairman's Report- It was brought to the attention of the Chairman that \$93,000 in checks issued from the BoE in June 2023 to Anthem BC/BS were never cashed. These checks will be reissued with no impact on the budget. Chairman Donaldson is looking for clarification from the BoE regarding how a reduction in the number of Special Education students would affect the future budget.

The Chairman was informed that \$168,000 for equipment was built into the purchase price of the new firetruck and has been held in an escrow account at the finance company. The Fire Department has requested a release of these funds. The Treasurer will need to take action to transfer the monies out of escrow.

Motion S. Hull second R. Baah to require the Fire Department to submit the bills for equipment to the BoF for review and approval.
