LISBON RECREATION COMMITTEE FIELD/PAVILION USE RULES & RESTRICTIONS

This Recreation Field Use Form must be signed by the representative of the organization wishing to use the field, and the LRC Field Coordinator, prior to using any Lisbon recreation fields. The completed form is your permission to use the selected field/pavilion. Carry it with you when playing on the field or utilizing the pavilion as proof of permission, if needed.

Field/Pavilion Use by Organizations

- No animals allowed on the fields at any time
- No alcoholic beverages allowed
- All garbage must be disposed of in trash receptacles
- If a field use changes, notify the LRC Field Use Coordinator to cancel or reschedule
- If porta-johns are in need of cleaning or damaged, notify the LRC Field Use Coordinator
- To preserve the fields, do not play on field during heavy rain
- If you have access to the gate, coaches may drive their equipment to their respective field to drop it off and then park in designated parking
- Motor vehicles are not allowed into the park area past the gate
- The gate must be locked after every use, no exceptions
- Don't allow anyone to borrow the keys or give out lock combinations to Lisbon Meadows Park
- If you have access to the Conex Box or shed, make sure the equipment is returned and stored correctly for the next coach
- Make sure all equipment is locked
- Report any misuse of the fields to the LRC Field Use Coordinator. Any suspected criminal activity should be reported immediately to the police 860-848-6500. In an emergency, dial 911.
- Certificates of liability must be valid for the dates of use, and will remain on file in the Town Hall.
 Should your liability insurance be canceled, the LRC has the right to cancel any further use of the fields by your organization until reinstated.

Pavilion Use by Private Individuals

- No alcoholic beverages allowed
- All garbage must be disposed of in trash receptacles
- If a use changes, notify the LRC Field Use Coordinator to cancel or reschedule
- Report any misuse of the fields to the LRC Field Use Coordinator. Any suspected criminal activity should be reported immediately to the police 860-848-6500. In an emergency, dial 911.
