Sean E. Sweeney presented a letter authorizing him to representP&P Invest Group and Naeem Khalid, manager. Attorney Sweeney stated that the past year there has been a significant reduction in foot traffic and business and therefore the property has significantly less value. He and his client feel that \$575,000 is more in line with the estimated value.

Christopher Glenney spoke on the application, reiterating that the property is a nonprofit and that the caretaker lives on the property to manage it and that he is paid by the Foundation to care for the property. The caretaker is allowed to rent the home on the property so that he can manage the property better.
