Chairman and Secretary of all administrative and executive boards, commissions, agencies, bureaus or other bodies must file with the Town Clerk no later than January 31<sup>st</sup> of each year a schedule of the regular meetings of such bodies for the ensuing year, and no such meeting may be held sooner than thirty (30) days after the schedule has been filed. Also, P & P, 102 River Road (Citgo gas station) was looking for a reduction in taxes due to the decrease in revenues suffered during COVID. Both appeals were denied at the March Hearings. Lawsuits have been filed, but there is no activity as of yet.
