Chairman Zelasky explained that the Board did not have the information regarding the incinerator at that time, on July 19th.

Robert Browne of Preston Allen Road commented that the incinerator was 2 years out from now, and that the Board could change the mill rate between now and then. He also reminded the Board that the firehouse could take five years to build and the \$11 million will not be needed all at once.
