## 5. Old Business

- a. Lisbon Fire Department Mr. Sparkman reported that the Town's Financial Advisor gave a presentation at a Board of Finance Special Meeting in regard to financing options for the proposed \$13m project. She will be returning to the Board of Finance at their next meeting for further discussion. Mr. Sparkman also reported that the Fire Department gave a presentation on the proposal for the purchase of a new fire apparatus at a cost of \$96,365.00. The Board of Finance approved the purchase through bonding at that meeting, but, after discussion with the Chairman, will re-evaluate funding options for the purchase at their next meeting.
- b. Route 12 Sidewalks LOTCIP Grant Mr. Sparkman noted that they are still considering options.
- c. Request, Lisbon Senior Center Window Replacement Bid Mr. Sparkman reported that a bid opening took place on July 9, 2021, with only two companies having submitted bids. Motion by R. Browne second by T. Sparkman to award the bid for Senior Center Window Replacement to Mattern Construction in the amount of \$54,605.00.

- d. Employment Opportunities Clerk to the Assessor / Nutrition Site Server Mr. Sparkman reported that the Clerk to the Assessor deadline for application does not close until July 23rd but that the Nutrition Site Server deadline closed on July 9<sup>th</sup>. Because the Commission on Aging would like to be involved in the interviewing process, it was the consensus of the Board to forward the three most qualified applications to the Commission on Aging for their consideration and final recommendation to the Board of Selectmen.

ARPA Funds – Mr. Sparkman reported that the first of two \$624,455.73 "American Rescue Plan Act of 2021" fund installments have been received by the Town and the funds will be placed in a Special Revenue account, to keep them separated from the General Fund. He also noted that the Council of Governments has offered to hire a person to act as a Regional Planner/ Recovery Coordinator and would be available to the Town for developing and vetting projects that are eligible under the funding guidelines.
