- b. Route 12 Sidewalks Mr. Sparkman noted that CLA Engineers has copied the Town on a letter to the Counsel of Governments, noting that the pre-application continues to be reviewed, and that the cost estimate is currently \$3.9 M and will likely increase.
- c. ARPA Funds Mr. Sparkman reported that the Town has received notice that the second round of funding has been requested and that the anticipated amount is \$624,455.73.
- d. Bundy Hill Bridge Mr. Sparkman reported that the notice of the project bid opening has been noticed in the paper, online and on the State contracting portal. Bid opening is scheduled for August 19, 2022.
- e. Spring Clean-up 2022 Mr. Sparkman reported that it has been completed.
- f. Small Town Economic Assistance Grant Program Mr. Sparkman noted that the aspplication is being prepared and will be submitted on schedule.
- g. FEMA, National Flood Insurance Program Community Assistance Act Mr. Sparkman reported that the Town is scheduled for a Community Asistance visit on Spetember 22, 2022

- a. Blight Ordinance Mr. Sparkman noted that the Town has been having some blight issues and that it may be in the best interest of the Town to revisit a Blight Ordinance.
