- a. Lisbon Fire Department It is noted for the record that Mark Robinson, Chairman of the Fire Station Building Committee, was present. He reported that the FSBC is researching the potential for HVAC inscentives, and will be sending the building project out for re-bid, to include a deduct alternate for the HVAC system.

- f. STEAP Grant Strawberry Fields Sidewalks, Phase III Mr. Sparkman reported that the Department of Transportation is finalizing the CONNDOT STEAP Administrative Guidelines for this round of funding and that it is now too late in the season to begin this project.
