After noting the numerous failures, repairs, leaks and inefficiency of the town hall heating/air system, Mr. Sparkman reviewed a proposal, from Frank Zaino & Associates, to provide mechanical design documentation (\$8,500) and construction and administration for the town hall heating/air conditioning system project (\$4,000).

A motion was made by J. Gwiazdowski, seconded by R. Browne, to hire Frank Zaino & Associates to provide the mechanical design documentation for the HVAC system in the town hall at a cost not to exceed \$8,500 and be the project construction administrator at an estimated cost of \$4,000.
