The bathroom renovations are completed. All sinks and toilets are now touch free. The men's room required new sinks to be installed.

Shooting Stars has applied to become a 501(c)(3) non-profit organization. The application was submitted on February 14, 2022 and the IRS is currently up to applications submitted before February 3, 2022. If approved, this will allow us to apply for grant money and organize fund raisers to offset the costs of activities and purchases through the Shooting Stars.
