A variety of programs are offered: from information and assistance; health, wellness and exercise programs; van transportation; meals, both at the center and the daily delivery of Meals on Wheels; benefits counseling; social and recreational activities, to intergenerational events.

Lisbon Senior Center is a highly recognized community focal point. The Shooting Stars, again, did fundraising and augmented your tax dollars to provide extras. They paid for built in bookcases in the library, also, entertainment several times during the year. They subsidized the holiday luncheon and paid for a gardener to care for the raised beds.
