Lee Szruba reported she had reviewed the new State of Connecticut regulations and handed out a sheet showing the Town regulations that will have to be changed. (Attached)

NEW BUSINESS:

1. Open Space.

Joe Lewerk reviewed maps from the Last Green Valley Institute and reviewed areas that could be valuable for open space and suggested the Commission make a list of properties for the purpose of preserving open space corridors for passive recreaction.

The proposed subdivision on Sullivan road was discussed. Motion was made by Joe Lewerk to recommend to the Planning & Zoning Commission they require a 100' wide conservation easement on the western and southern boundries of the G. C. Lisbon LLC project on Sullivan

Road. The purpose being to provide connectivity with conservation lands west and south of the proposed subdivision. Second by Rick Hamel.

VOTE UNANIMOUS, MOTION CARRIED.

RE: CT DEP memo of March 3, 2010:

Legislature amended the CT Inland Wetlands and Watercourses Act so that any IW permit approved only between 7/1/2006 and 7/1/2009 is good for at least 6 years. If the permit holder requests a renewal (and there has been no substantial change that would require a new permit, and no enforcement action has been needed), that renewal can be for up to 5 years, making a maximum of not more than 11 years. Renewed permits originally issued outside of these dates have a maximum life of 10 years.

This mean we need to revise Section 7.10 and Section 11.6 of our Regulations to reflect these legislative changes.

The time line would be:

on April 20th – vote to revise Regulations to incorporate legislative changes of Section 3 of Public Act 09-181

for May 18th - copy of legal notice and proposed revisions to DEP

on June 8th - 1st legal notice in newspaper

on June 11^{th} – file copy of proposed revisions with Town Clerk on June 15^{th} – 2^{nd} legal notice in newspaper

on June 22nd - hold public hearing prior to regular meeting

on June 22nd - during regular meeting (considering public hearing comments), vote to adopt the proposed revisions, including effective date

by June 25th - file revised regulations with Town Clerk

RE: Declaratory Ruling in the matter of Geographic Information Systems

This appears to address the question of what GIS data is considered land surveying, and in which instances it must be used under the supervision of a licensed surveyor and in which instances it does not. It does if it is an authoritative reference for spatial elements that include property boundaries, fixed works or topography or deal with safeguarding life and property. It does not if it is a non-authoritative reference depiciting unqualified approximate boundaries, etc. for the purposes of planning, infrastructure management, tax assessment, etc.

The rest of the document goes into detail about what the phrases quoted above mean.

RE: Declaratory Ruling in the matter of Maps and Plans in Digital Form

This appears to address the release of unsealed (unsigned and validated) materials, especially in the form of digital format for use by municipalities. The concern is the ease with which transparently editable and digital formats can be invisibly modified without the knowledge or approval of the preparer. It mainly concerns licensed land surveyors and professional engineers.
