- Robert Roark, 5 Sylvandale Road Chairman Hamel noted for the record that the applicant,

 for the record that the Zoning Board of Appeals previously approved Mr. Roark's application to

- 2. Town of Lisbon, CLA Engineers, Bundy Hill Road Bridge Replacement / Blissville Brook Kyle Haubert of CLA Engineers, was present to give an overview of the project. Projected start date is July, August, or September of 2021. The Town will be notified when the road would be closed to traffic on each side of the culvert for proposed activity. Motion was made by M. Robinson second by W. McIntosh, Sr. to accept Application #20-03.

3. Robert Lattanzio, Boundaries, LLC (Agent), 140 Kimball Road – Jacob Faulise of Boundaries, LLC was present and gave an overview of the planned project. This property is identified as Lot 5 as part of the 2005 subdivision. Wetland delineations were made by Healy & Associates back in 2005. The areas of concern (88 feet from the wetlands at the corner of the house) in the upland area will need to be delineated again before the site walk. Boundaries, LLC will perform re-delineation. Motion was made by J. Lewerk second by W. McIntosh, Sr. to accept Application #20-04.

- f. Reports of officers, Committees and staff Joseph Theroux, Conservation Officer gave a brief update of the following:
 - 2025 Pleasant View Cove complaint that someone started clearing property pushed off all the brush and vegetation. Owner getting ready to construct the septic system and house the Commission approved back in 2016.
 - 21 Strnad Road issued a wetlands violation a few years ago. Owner assured Enforcement
 Officer Theroux he will not be working in wetlands area. Owner will only be grading and
 regrading.
 - 3. 132 Kimball Road Enforcement Officer Theroux made several visits from numerous complaints of excessive amounts of manure on property. Owner is in the process of complying.
 - 4. 50 Ross Hill Road Enforcement Officer Theroux was contacted by owner that he will be starting to clean up his stream channel which Commission approved last year.

g. Unfinished Business

- 1. Wetlands Violation Douglas & Vera Hueg, 26 Regina Road Conservation Officer Joe Theroux reported that he met with Mr. Hueg on July 7, 2020. Mr. Hueg obtained a 275-gallon water tank and released 275 gallons of ultraviolet dye which soaked into the ground. None of the dye went into the culvert during the time that Mr. Theroux was present. Mr. Theroux is currently satisfied with the abatement process. No further complaints have been made. Kropp Environmental recommended installing a ventilation system. Mr. Theroux will follow up on the ventilation system being installed and the dirt in the dumpster being removed, and will report back next month.
