Call to Order

The Special Meeting of the Conservation Commission was called to order by Richard Hamel, Chairman, at 7:00 pm.

1. Application #18-04 – Dakota Construction, LLC – 31 Strawberry Street – Damien Sorrentino of Boundaries, LLC and Peter Zvingilas of Dakota Construction were present. He reminded the Commission that they had conducted a field walk just one week prior to this meeting. He stated the proposed activity of constructing a single-family residence and associated improvements to the lot, would have no adverse impact against the lot's natural resources.

Motion was made by M. Robinson second by J. Lewerk to approve application #18-05, with the condition that the applicant contacts Joseph Theroux, Conservation Officer, prior to beginning the project.


