a. Call to Order

The Regular Meeting of the Conservation Commission was called to order by Richard Hamel, Vice-Chairman, at 7:00 P.M.

b. Reading of minutes of previous meeting(s) and action thereon:

 - 1. J. Gwiazdowski 180 Newent Road Atty. William McCoy of Heller, Heller & McCoy, 736 Route 32 Uncasville, was present to represent the applicant, John Gwiazdowski. He stated the restoration plan was subject to the court order, and said it would be simple grading of disturbed area. He said that the applicant will remove piles from the area and use as loam for seeding disturbed areas. No grading to take place.

Staff J. Theroux stated he had the following concerns:

- 1) The road to the river allowed sediment to discharge into the river, after the Commission ordered J. Gwiazdowski to create a berm as prevention. He recommended that as a part of the remediation, a site walk should be scheduled and a sediment basin should be ordered.
- 2) The situation on the north side consists of storm water being discharged due to recent activity on the site.

The applicant J. Gwiazdowski, suggested a berm of 4 foot or 5 foot high to end the driveway before the river.

Atty. W. McCoy stated that the applicant would be in front of the judge again on June 24th. The Commission scheduled a site walk for 180 Newent Road on Wednesday, May 28, 6:00 P.M. Motion by J. Lewerk second E. Freidenfelds to accept application #14-03 for review.
