a. Call to Order

The Special Meeting of the Conservation Commission was called to order by Richard Hamel, Chairman, at 7:00 pm.

b. Reading of minutes of previous meeting(s) and action thereon:

A motion was made by L. Szruba second by M. Robinson to approve the previous meeting minutes of 4/16/2019 and 3/19/2019.

c. Application – Joseph Sudik, 68 & 64 Lisbon Heights Road – Mr. Sudik presented his plans to the Commission. He explained that his father originally had the acreage approved for 16 parcels, but only 7 now remain. He is proposing activity within 100 feet of the upland review area, but not within the wetlands themselves. His plans are to combine the two parcels. Mr. Theroux, CEO, stated that the parcel where construction is proposed, is completely flat.
