2020 Presidential Election



Registrar of Voters

The "unusual election season" continues. The Presidential Election will be held on Tuesday, November 3, 2020. Polls in both districts will open at 6:00 a.m. and will close at 8:00 p.m.

- District 1 votes at Lisbon Town Hall
- District 2 votes at the Lisbon Senior Center

COVID-19 emergency regulations will be in effect, same as they were for the Presidential Primary held in August. In-person voting will continue with the one-way entrance and exit locations at both polls. Six-feet social distancing markers will be there, and we again ask voters to bring their own pen (blue or black) and masks are requested.

Absentee Ballots

Absentee ballots will be available during the first week in October. Presently, we are being told that the absentee ballot applications are being sent to all voters from the office of the Secretary of State and then the ballots will be available from the town clerk. The applications can be mailed back to the clerk or deposited in the election drop box located at the town hall.

Are You a Registered Voter?

You can check your voting status at www.lisbonct.com Home page under 'Voter Registration'. If you are not a registered CT voter, this page will direct you to the online registration process. The registration deadlines for the November 3rd, 2020 are:

- October 27th is the cut off for post-marked mail-in, electronic and in person registrations.
- Nov 2nd is the cut off for limited registrations for those who have moved into town, turned 18 or became a citizen since October 27, 2020.
- Election Day Voter Registration is available at the Town Hall between the hours of 6:00am to 8:00pm. You will register and vote in a separate area at Town Hall instead of the Town Hall polling location. Please plan to arrive early in the day because you must be registered by 8: 00 p.m. in order to vote. You will need to provide proof of identity and residency as well as follow all Covid-19 regulations of mask wearing and social distancing.

Voting By Absentee Ballot

If for some reason you are unable to vote in-person on Tuesday, November 3, 2020, you can vote by absentee ballot. In CT, you need to request your ballot with an Absentee Ballot Application. Per Public Act 20-3, COVID19 has been added as an approved reason to make this request.

Obtaining an Absentee Ballot Application

The CT Secretary of State's office will be mailing an Absentee Ballot Application to every registered voter in CT by the middle of September. You can also obtain an Absentee Ballot Application from the Town's website at https://www.lisbonct.com/town-clerk/pages/elections

Completing the Absentee Ballot Application

- Fill application out including contact information in case there is a problem with your application.
- You must state the reason you are requesting an absentee ballot.
- Sign your application. If you receive assistance with your application, please have the person you authorize to assist you fill out Section IV.

Returning Your Absentee Ballot

There are several ways to return your Abs Application to the Town Clerk:

Receiving Your Ballot

Ballots will begin to be issued on October 2nd. (Overseas/Military blank ballots are available on September 15th). Please note that ballots must be mailed or given directly to the elector. No one can pick up a ballot for someone else. If timing does not allow for a ballot to be mailed to you, call the Town Clerk's Office to arrange to pick up your ballot. Please bring a mask and an ID with you.

Filling Out Your Ballot

Once you have completed your ballot, insert it into Envelope B and <u>sign it</u>. Your ballot will be rejected if it is not signed. Then, insert your signed Envelope B into the return envelope.

Returning Your Ballot

Your ballot must be received by 8:00pm on Tuesday, November 3, 2020 in order to be counted. You can return your ballot via:

Assessor's Office

In accordance with Connecticut General Statute 12-40, all persons who are liable to pay taxes on tangible personal property belonging to them on October 1, 2020 are hereby notified that they must file a declaration of their personal property on or before November 1, 2020, with the Assessor, or be subject to an estimated assessment and the statutory 25% penalty. Various exemptions are explained on the declaration and available if filed on time.

Personal property includes, but is not limited to, non-CT registered motor vehicles, unregistered motor vehicles (including junk autos), campers, all business machinery, equipment, tools, commercial furniture and fixtures.

NO DECLARATION IS REQUIRED FOR MOTOR VEHICLES REGISTERED IN LISBON, CT

NO DECLARATION IS REQUIRED FOR REAL ESTATE

The filing deadlines for various exemptions and classifications are as follows:

PUBLIC ACT 490

All applications for classification of farm or forestland must be received by October 31, 2020.

RENTERS REBATE

Residents 65 years of age or totally disabled may be eligible for a rent rebate under CT State law; income guidelines apply and are adjusted each year. Applications must be filed on or before October 1, 2020 with the Assessor's Office.

DISABILITY

Persons totally disabled receiving SSD benefits may be eligible for a \$1000 property exemption. Proof of award and application must be submitted by January 31, 2021.

VETERANS

Veterans claiming disability exemption must submit proof from the Veterans Administration. PA 85-573 allows veterans an additional exemption if their income is within the approved limits. This application must be filed by October 1 bi-annually.

HOMEOWNERS & TOTALLY DISABLED

Residents 65 years of age or totally disabled may be eligible for a tax credit on real estate; income guidelines apply and are adjusted each year. Applications will be available February 1, 2021 and must be filed on or before May 15, 2021.

- HOME page the HOME page is the default page that comes up when you type in the domain name: www.lisbonct.com. The HOME page offers the ability to view your taxes and pay them online (which includes printing out receipts for taxes you may have dropped off in the drop box), simply by clicking on the button titled \$ Tax Bill Inquiry & Payments.
- Another helpful tip: did you know that you can Subscribe to and receive email notices of Agendas and/or News and Announcements from the Boards, Commissions or Committees you are interested in? You may subscribe to one, a few, or all!





Hiding in Plain Sight -


Lisbon Town Hall's Incredible Mural

Anyone who has had the opportunity to sit in on a Board meeting at Lisbon Town Hall is very much aware of the amazingly large painting that hangs on the wall in the conference room. It depicts the historic Burnham Tavern (that ancient house currently being renovated by the Lisbon Historical Society on North Burnham Highway), with Major General Marquis de LaFayette and his men, stopping at the Tavern on their way to Rhode Island in 1778.

Many Town residents may not be aware that this work of art, completed in 1975, was created by local Scotland, CT artist, David Wagner. Mr. Wagner, a self-taught artist, has been incredibly prolific throughout his career as a painter, and his acrylic paintings grace the walls of other town halls including Griswold, Groton and Plainfield. The Mohegan tribe commissioned him to create 102 works of art of the Eastern Woodland people, and the Old Newgate Prison and Copper Mines in East Granby, CT has a series of five of his murals. Work by the artist also hangs in Philadelphia, Providence, and overseas.

Mr. Wagner has illustrated numerous books utilizing his unique style and interpretation of historical figures and places. The most recent book is called "Mystic Fiasco: How the Indians Won the Pequot War".

From The History Books

FEDERAL CENSUS AND GENEALOGY

In 1790, Article 1 Section 2 of the United States Constitution initiated the Federal Decennial Census, which is conducted every 10 years. This was done to gain information about the American population and the economy.

Federal Marshalls conducted the first census going door to door. This was done in the 13 states and the districts of Maine, Vermont, Kentucky, and Tennessee. The name of the head of household and the ages of all people in the household recorded. African Americans were counted as three fifths of a person. Native Americans were excluded.

The first Federal Census in 1790 took 18 months to complete and counted 3.9 million people. The report allowed Congress to determine persons residing in the United States for tax purposes as well as delegating seats for the House of Representatives.

Only one copy of the census schedule was to be held by the clerk of the district court in their respective area. In 1830, Congress passed a law requiring the return of all decennial census reports from 1790 to 1830. At this time, it was discovered that many of the 1790 original census records had been lost or destroyed. Delaware, Georgia, Kentucky, New Jersey, North Carolina, and Virginia suffered district losses but some were able to recreate the census from tax lists and other records.

The Federal Census benefits each community, based on its population totals. It is broken down by sex, age, race and other factors. Communities benefit when the count is accurate as the government determines federal funding for schools, hospitals, public safety, infrastructure, and other programs, on a federal, state and local level.

When using the census to research family genealogy, it is best to keep the following in mind:

- There is a 72 year restriction for accessing Federal Census records. The 1940 Federal Census was released in April 2012. The 1950 Federal Census will be released to the public in April 2022. This helps to protect the privacy of living individuals.
- Much of the 1890 Federal Census was lost to fire and

water damage in January 10, 1921. Surviving fragments of census records are from Alabama, District of Columbia, Georgia, Illinois, Minnesota, New Jersey, New York, North Carolina, Ohio, South Dakota, and Texas. Some fragments are of townships, or counties. No complete Federal Census exists for any state. There is a database index to individuals enumerated in the 1890 Special census of Civil War Union veterans and widows of veterans at the National Archives Record Administration. Confederate veterans may be listed as well.

- When looking for a specific person, it is important to look at the family name. There are sometimes spelling errors, ages may not be correct, and the location of birth may be inaccurate.
- It is recommended to start with the 1940 Federal Census (or the most current record released) and work backwards through each census record. Start with your immediate family and then your grandparents. Ask them questions if they are still around! Obituaries have lots of information about date of birth, date of death, family members, towns lived in, siblings and parents, military status, involvement in community organizations, the church they attended or other religious affiliation.
- Consider that there may have been potential name changes when your ancestors entered the United States.
 Some immigrants had language barriers and didn't know English. Even if they did speak English, it was sometimes difficult for the interviewer to understand them, and names were spelled phonetically. Some people didn't know their date of birth or how old they really were.
- There are many internet sites to obtain information regarding research. Some are free and some charge a subscription. It is important to remember that not all information is 100% accurate, so it is recommended to have 5 or more sources of information for each category. Keep all information until you can weed out the wrong information with the accurate.
- www.archives.org offers genealogy books that can be read on-line for free; www.ancestry.com is a good source of information from many different resources, but requires a subscription. Sometimes these sites have census records, birth dates, death dates, marriage dates, wedding announcements, social gatherings where family members were present, and political news of the times.



Lisbon Historical Society Quarterly Notes

Friends and neighbors, the Lisbon Historical Society continues to go about the business of fulfilling our mission during this extraordinary time. We are busy sorting cans and bottles, scheduling maintenance and projects whilst maintaining social distancing. In-person meetings and summer open house at the John Bishop House are on hold for the time being, however our social media platforms, Facebook and webpage, https://lisbonhistoricalct.org are live, please visit them for updates and information.

Cans and Bottles: Can and bottle news is not usually the lead off happening for the Historical Society, but with the shutdown of the redemption centers due to Covid-19 we collected a 5 -month inventory and had finally run out of storage space. On Thursday, July 23, a horse trailer load was delivered to an operating redemption center in Stratford, CT discovered by Ken Mahler. In an hour and a half a team of LHS members and friends loaded bags containing 30,261 aluminum cans, and 27,383 plastic bottles in the back of the pickup truck and trailer generously donated by Terry Joseph, of Cedar Knoll Farm. Many thanks go out to all the hands on deck for this for making this project a success: Ken Mahler, Christine Strick, Marcia Shafer, Sharon Gabiga, Paula Adams, Kim Sperry, Mark Sperry, and especially to Terry for his time, labor, trailer and good humor.

Burnham Tavern Update: We have completed the purchase of the cedar taper cut roof shingles and are waiting scheduling as well as the chimney repointing.

John Bishop House Update: the carriage shed, can and bottle shed are both resealed, and the window trim painted.

Wanted: New Members!

The Lisbon Historical Society's success is contingent upon the dedication of our members. We are a 501 (c) 3 nonprofit volunteer organization; part of our mission is to promote an interest and foster appreciation of the rich history and culture of the town of Lisbon, and we are stewards of three important town owned properties. We are still accepting cans and bottles, except for the following: Poland Springs water bottles with the red strip around the label, Gatorade, Snapple, tea beverages, wine bottles, plastic milk jugs, and all others not marked CT. Additionally, it is impossible for the bar code readers at the redemption centers to process crushed aluminum cans and plastic bottles. We do our best to pop bottles back in to shape but those we cannot, and the crushed cans, subsequently end up in the recycling bins and over the year that amounts to a lot of lost nickels. Many thanks go out to contributors to our can and bottle redemption program.
