# **Budget Schedule**

March 10—General Government and Board of Education Budgets are due to the Board of Finance.

March 15—Regular Meeting.

March 22—General Government and Board of Education Budgets to be presented to the Board of Finance. Discussion/ Possible Vote.

March 29—Budget discussion and possible vote.

April 4 — Public Hearing on both budgets to take place at LCS Cafeteria. Budget materials will be available for public review in Town Clerk's Office five days prior to the hearing.

April 12— Discussion and Possible Vote on both budgets.

April 19— Regular meeting. Discussion/Possible Vote.

May 1 — Annual Town Meeting to take place at LCS Cafeteria. Per ordinance, it is the first Monday in May. The Capital Non-Recurring account will be voted on at this meeting. The GG and BoE Budgets will NOT be voted on at this meeting, except to send them to referendum.



Referendum will take place approximately 1-2 weeks after the Town Meeting.

Mill rate to be set approximately 1-2 weeks after the referendum.

# **New Lisbon Fire Station Progress Update**

Since the approval of the new fire station on September 8, 2021 bonding was secured and a Fire Station Building Committee was established. Members appointed to the committee include Chairman: Mark Robinson, Vice Chairman: Allen Bergeron, John Cingranelli, Josh Cingranelli, David Croughwell, Miles Lafemina, James Labonne, Robert Browne, Wayne Donaldson and alternates Michael Civardi and Michael Zelasky.

The committee finalized plans to bid the project with Mitchell Associates Architects, PLLC of Voorheesville, New York and CLA Engineers of Norwich. This included approvals from the Conservation Commission, Zoning Board of Appeals, Planning and Zoning Commission, Fire Marshal and Building Inspector.


The project consists of separate site work preparation, which was awarded to Roma Construction Company of Jewett City. The contract price was \$1,250,000.00. Site work began in August 2022, which included blasting, removal of ledge and material, site grading, drainage, a retention pond and a retaining wall.

Clerk of the Works has been awarded to Construction Advocacy Professionals, LLC of Preston.

Finally, the building committee rebid the building phase of the project after first round bids were over the projected budget. We are pleased to announce the Town has awarded Orlando Annulli and Sons, Inc. of Manchester the building construction contract at a cost of \$9,259,000.00; commencing February 27, 2023 with a completion date of April 22, 2024 (420 calendar days).

The filing deadlines for various exemptions and classifications are as follows:

# HOMEOWNERS & TOTALLY DISABLED

Residents 65 years of age or totally disabled may be eligible for a tax credit on real estate; income guidelines apply and are adjusted each year. Applications are accepted February 1, 2023 and must be filed on or before May 15, 2023.

# **RENTER'S REBATES**

Residents 65 years of age or totally disabled may be eligible for a rent rebate under CT State law; income guidelines apply and are adjusted each year. Applications will be available April 1, 2023 and must be filed on or before October 1, 2023.

# PROPERTY TAX EXEMPTIONS FOR BLIND OR TOTALLY DISABLED PERSONS

Connecticut law provides for a \$3,000 assessment exemption for taxpayers who are legally blind. Proof of the blindness (certification by a qualified medical practitioner) must be received by October 1, 2023.

Connecticut law also provides for a \$1,000 exemption for totally disabled persons who are receiving benefits under a federal, state or local retirement plan, which contains requirements comparable to those of the Social Security Administration. Proof of disability must be received by October 1, 2023.

# VETERANS

Veterans claiming disability exemption must submit proof from the Veterans Administration. PA 85-573 allows veterans an additional exemption if their income is within the approved limits. This application must be filed by October 1 bi-annually.

# PUBLIC ACT 490

All applications for classification of farm or forestland must be received by October 31, 2023.

# **New Fishing Regulations in Effect**

Fishing licenses are required to fish in all Connecticut waters. Your Lisbon Town Clerk's office is an approved DEEP Sportsmen License Vendor, or you can get your Sportsmen licenses on line at CT.aspirafocus.com/ internetsales. Key changes to fishing regulations effective 12/27/2022 are available on the Secretary of State website. The closed season has been removed. In an effort to conserve & protect the environment, the Fisheries Division of the DEEP will be printing a limited number of guidebooks in 2023. A PDF version is available on their website. The Fisheries Division encourages everyone to make use of the digital fishing guide to reduce wasted paper.

The office of the Town Clerk, also in an effort to conserve & protect the environment, has encouraged the members of various Town boards and commissions to receive their agenda and minute packets in electronic format, thereby eliminating the costs of postage, envelopes and paper. It has the potential for substantial savings for the Town.

**Be aware** that the State of Connecticut now requires proof of license to kennel your dog. Dog License reminders will be sent out in May and new licenses will be issued the entire month of June. An up-to-date rabies certificate will be required at that time in order to obtain a license.

# Lisbon Historical Society Quarterly Notes

Recently an inquiry was made as to the provenance of a house on Hamburg Cove in Lyme that was originally located on the corner of Ross Hill Road near Penny Lane. The "old Burnham place" was built about 1780 on 200 acres "across the street" from the Burnham Tavern on land willed to James Burnham by his father. James was a cousin to Captain Benjamin Burnham. Over the centuries, the house came to be owned by a Brown, Palmer, Fitch and Sudek before it was taken apart piece by piece, and relocated to Lyme. Fireplaces, chimneys, the foundation from the ground up, great slabs of granite stepping stones and the front steps were also moved. When the house was restored in Lyme, the chimney and stairs were returned to their original locations. Members of the Historical Society toured the house in Lyme to compare the style and construction to the Tavern. While the Lyme house does not have a ballroom, the main house layout is nearly identical. The two photographs are before the move and after restoration.



Anshei Israel Synagogue Update: Building and Grounds committee members Ken Mahler, Kevin Shafer and Steve Lawhead, dug out the west and north side foundation and lay drainage pipe to prevent the sill from rotting. Crushed stone was placed around the entire building to avoid rain splashing mud on the sill & skirt boards. The project took place over three gloomy, rainy days with freezing temperatures in December.

The synagogue, no longer a house of worship, is a museum opened by appointment (for more information, email Paula Adams at padams60@sbcglobal.net). Additionally, a booklet on the history of the synagogue, *A Refuge in the Country*, is available upon request and at the Lisbon Town Hall.

# Unacceptable Waste Materials Being Reported by Wheelabrator

Wheelabrator Lisbon, Inc. reports that recent inspections of waste loads delivered by the hauler that services the Town of Lisbon has revealed an unacceptable amount of materials in these loads to be recyclables. Wheelabrator is required to report loads that contain 10% or more recyclables in its waste collections, and the current percentage for the Town of Lisbon is 14%.

If you are a Lisbon resident and do not have a recycle bin, contact the Selectman's office at 860-376-3400 and arrange to pick one up at the Town Hall.

A list of unacceptable household waste may be found on the next page. This includes anything that is on your recyclable materials list.

In short, *please remember to recycle*. The Recycling Zone Map, Recycling Calendar, Recycling Do's and Don'ts, and general Recycling Information may be found under the "<u>Town Services</u>" link on the Home page of the Town website.

"Municipal Solid Waste" means solid waste from residential, commercial & industrial sources, excluding solid waste consisting of significant quantities of hazardous waste as defined in section 22a-115, land-clearing debris, demolition debris, biochemical waste, sludge & scrap metal. CGS 22a-207(23)

Special Waste including processed construction and demolition wood when approved by application prior to receipt and renewed annually, no later than 12 months of previous application.
