Town Clerk's Corner

June is Dog License Renewal Month!!!

As a resident of Connecticut, it is the law to license your dog yearly through the Town Clerk's office of the Town in which you reside beginning as soon as the dog has reached the age of 6 months. Newly obtained dogs must be licensed within 30 days of new ownership. In order to license a dog, proof of a current rabies vaccination with expiration date is required and if applicable proof of the dog being spayed or neutered. The fee to register a dog is \$8.00 for a neutered/spayed dog and \$19.00 for an unaltered dog. Please include a copy of any updated rabies certificate, if required. If you have a new dog, please send the dog license form with the necessary supporting documents and payment (the form may be found https://www.lisbonct.com/town-clerk/pages/doglicenses). Dog licenses expire on June 30th of each year. Therefore, license renewals occur yearly in the month of June. If a dog is not registered in a timely fashion, there is a statutory fee of \$1.00 per month assessed beginning July 1st.

Assessor's Office

REVALUATION

The Town of Lisbon is undergoing a State mandated revaluation of all real estate parcels, which will be effective for the October 1, 2021 Grand List. We have contracted with Vision Government Solutions to assist the Assessor's Office with this project. Your cooperation is greatly appreciated.

Pursuant to Connecticut State Law, every municipality must complete a town-wide revaluation every five (5) years. A revaluation determines the current fair market value of all real estate in town, both commercial and residential. It equalizes the values of all properties for the purpose of a fair distribution of the tax burden.

Employees of Vision Government Solutions are currently collecting data and performing field reviews in Lisbon. All Vision employees are wearing identification. RENTER'S REBATES

Senior or disabled low-income renters may be eligible for a partial rebate of rent and utility bills, excluding telephone and cable. The filing period is April 1 through October 1.

PROPERTY TAX EXEMPTIONS FOR BLIND OR TOTALLY DISABLED PERSONS

Connecticut law provides for a \$3,000 assessment exemption for taxpayers who are legally blind. Proof of the blindness (certification by a qualified medical practitioner) must be presented to the Assessor prior to October 1 in order for the exemption to be applied to that assessment year's tax bill.

Connecticut law also provides for a \$1,000 exemption for totally disabled persons who are receiving benefits under a federal, state or local retirement plan, which contains requirements comparable to those of the Social Security Administration. Proof of disability must be presented to the Assessor prior to October 1 in order for the exemption to be applied to that assessment year's taxes.

From The History Books

The History of Medicine in our Town

If you are a history buff, you likely read historical novels or watch movies with historical plots. Here is a run-down of medical terms and conditions you may come across, with their contemporary descriptions:

- Ablepsy = Blindness.
- Apoplexy = Stroke or a cerebral hemorrhage/bleed
- Barrel Fever = Alcohol poisoning
- Biliousness = Jaundice
- Black Gog = Depression
- Blood Poisoning = Sepsis or Septicemia
- Bone Shave = Sciatica (sciatic nerve inflammation)
- Brain Fever = Meningitis
- Bright's Disease = Kidney failure
- Canine Madness or Hydrophobia = Rabies
- Canker Sore (of the lip or mouth) = Herpes Simplex
- Catarrh = Nasal Congestion and Runny Nose
- Change of Life = Puberty and/or Menopause
- Child Bed Fever, Puerperal Fever, or Metritis = Puerperal Fever ("puerperal" means "childbearing")
- Chilblain = Swelling of extremities caused by exposure to cold
- Colic = Colic (abdominal pain and cramping)
- Congestive Fever = Malaria (caused by a mosquito bite)
- Consumption, Wasting Disease, or Lung Sickness = Tuberculosis
- Convulsions, Falling Sickness, or Jackson's March = Epilepsy
- Dropsy or "Swollen with water" = Congestive heart failure
- Dropsy of Brain = Encephalitis (caused by a bacteria or virus)
- Fatty Liver = Cirrhosis of the Liver (commonly from excessive alcohol intake)
- Green Sickness or Green Fever = Anemia (blood loss anemia)
- Grip or Le Grippe = Flu or Influenza
- Infantile Paralysis = Polio
- Jail Fever or Camp Fever = Typhus or Typhoid Fever (caused by Salmonella bacteria)
- Lockjaw (difficulty opening or closing jaws) = Tetanus
 Lumbago = Back pain (occasionally still used today)
- Mad Cow Disease = Creutzfeldt-Jakob Disease (caused by eating infected beef)
- Melancholia = Severe Depression or Sadness
- Mania or Acute Mania = Mental Illness or Dementia
- Milk Leg = Blood clots in a woman's legs developed after delivery of a child

- Mortification = Gangrene (death of an organ or tissue)
- Nostalgia = Homesickness
- Pest House = Isolation home or Quarantine home
- Quincy = Tonsillitis
- Rheumatism = Arthritis
- Scarlet Fever = bacterial infection of the skin and throat from a Strep bacterium
- Scrivener's Palsy = Writer's Cramp
- Shaking or Tremors = Parkinson's Disease.
- Ship's Fever or Leprosy = Hansen's Disease (caused by a bacteria)
- Softening of the Brain = Dementia or Alzheimer's Disease
- Saint Anthony's Fire = Erysipelas (a contagious skin dis ease)
- Saint Vitus Dance = Huntington's Disease (a genetic disorder that causes the progressive breakdown of nerve cells in the brain)
- Uncontrolled Tremors or Palsy = Paralysis
- Went Under = Anesthesia
- White Fever = Pneumonia

I located many of these terms while I was collecting information for this article and I knew a few from my days as a nurse. There are many more that you can find on the internet if you look under old medical diagnosis or history of medicine.

Lisbon Historical Society Ouarterly Notes

On April 18, 2021, the Lisbon Historical Society suffered a heartbreaking loss with the passing of Albina Frederick, a lifelong resident and longtime Society member, at the age of 97. Albina's volunteer contributions over the decades set the standard for the rest of the membership. She devoted endless hours to bake sale fundraisers, staffed the Bishop House, gave tours, provided research and her famous baked beans. Most importantly, Albina participated in an oral history video produced by Ken Mahler recounting her life before electricity in the 1920s and 30s and the impact of the modern conveniences that followed. Although retired from active membership, the Lisbon Historical Society deemed Albina's influence was so significant that in May of 2016 we acknowledged her with Lifetime Honorary Membership.

Burnham Tavern Update. The wood ordered for the slats across the rafters on which the wood shingles are nailed is delayed once again this time due to a breakdown of equipment at the mill. The carpentry team is now scheduled to begin work on the rear Burnham Tavern roof later this month,

John Bishop House Update. The museum remains closed due to Covid restrictions, but we are looking forward to reopening in the near future. Work on the grounds continues with the replanting of the herb garden and the annual Three Sisters garden behind the picket fence.

Cans and Bottles Update. Donations since the start of FY 2020 -21 are healthy due to Covid restrictions on local consumer redemption sites. Although the state legislature is considering adding new products to the redemption stream, Gatorade, Snapple, tea beverages, wine bottles, plastic milk jugs, Poland Springs water bottles with the red strip around the label, and all others not marked CT are not redeemable and should be recycled in blue bins on trash day. Additionally, it is impossible for the bar code readers at the redemption centers to process crushed aluminum cans and plastic bottles. We do our best to pop bottles back in to shape but those we cannot, and the crushed cans, subsequently end up in the recycling

bins and over the year that amounts to a lot of lost nickels. Many thanks go out to contributors to our can and bottle redemption program.

Trail Committee

The Trail Committee spent the spring maintaining and improving the Burnham Tavern Trails. We were fortunate that the Lisbon Centennial Lions Club assisted with clean up along Kimball Rd and North Burnham Highway, collecting 14 bags worth of trash. Trail Committee volunteers also improved the middle trail, laying down donated wood chips to smooth the rough patches and those areas that tend to get muddy. You may also notice pink flags and activity in the area between the parking area at 62 Kimball Rd leading to the wooded area opposite Kimball Heights Lane. A new trail is in the works that will wind its way through the forest, roughly parallel to Kimball Rd to a point opposite Kimball Heights Ln. This portion of the property is thick with mountain laurel and princess pine carpeting the forest floor. From there the new trail will proceed north along the stone walls bordering the farm fields of the Burnham Tavern, finishing at the Strawberry Fields end of the middle trail. The new trail will add about a half mile to the trail network, providing a view of the seasonally changing fields and pastures as well as the Tavern. The parking area and trails are open from dawn to dusk for passive recreation (no motorized vehicles). Please remember to take out what you bring in to include pet waste and enjoy this precious town resource.

Town of Lisbon Spring Clean-up

Observations and Guidelines

For many years, the Town of Lisbon has offered a town-wide spring clean-up for its households in the early summer. Lisbon residents have greatly appreciated this service as it offers a convenient means of disposing bulky items not normally accepted by their trash hauler.

In recent years, however, Lisbon's Spring Clean-up program, the intent of which is to provide the opportunity for households to dispose of items such as an old couch or a tire, has been abused. Residents are placing out quantities far in excess of acceptable numbers; bringing home items from commercial businesses; and bringing home out-of-town items for disposal here in Lisbon. This program is not designed as a means to dispose of so many items.

Therefore, the following requirements will be strictly enforced (see page 2):

Spring Clean-up Guidelines

TIRES: Limit of four (4) per household. Tires over this limit will not be removed. Empire Tire in Plainfield will accept scrap tires (for a fee).

TIRES with Rims: Tires on rims cannot be accepted and will not be picked up.

Excessive Quantities: Lisbon households have been placing out quantities far in excess of what one (1) household would normally produce. For example, a single household does not produce 2 or more couches, year after year. When such quantities are observed, it is believed that the material is coming from other towns. This practice drives costs up, making it harder for the Town to cover costs each year.

Propane Tanks: Lisbon does not accept propane tanks, including home BBQ tanks. These tanks should be brought to designated retail locations for exchange.

Early Place Outs: Do not place items for spring clean-up weeks prior to the start of clean-up. This practice leads to scavenging, causing material to be thrown everywhere.

Please Note: A flyer with the exact start date for Spring Clean-up and a list of acceptable items will be placed in the recycle bins at each Lisbon household in the near future. Spring Clean-up information will also be online at **www.lisbonct.com**.

WHERE?

Acceptable items will be picked up at curbside. All items <u>must</u> be at the curb by 7 a.m. on June 7, 2021

WHAT?

Acceptable and Non-Acceptable items are listed below.

Acceptable Items

(Keep different items seperate at curb)

Furniture:

Springs removed, especially from sleeper sofas

Appliances:

(2 per household) Doors must be removed

from refrigerators and freezers.

Leaves:

In large 30 gallon brown paper leaf bags.

No plastic bags.

Old Wood

& Pallets:

(No longer than 3 feet in length)

Other Metal

Items:

(Must be separated from wood and furniture)

Automobile

Tires:

(Tires on rims will not be accepted)

Items NOT Accepted

(These items will not be picked-up)

NO: Refuse, Recyclables, Rubble

(stone, concrete, brick, construction debris)

NO: Household Hazardous Waste

NO: Car Parts, Auto Batteries, or Antifreeze: (residents may take

these items to the Willimantic W. Paper's Recycling Site

on Roode Road in Plainfield).

NO: Propane Tanks, or 55 Gallon Drums

NO: Contractor, Business, or Industrial Debris

NO: Electronics - TVs, Computers, etc.

NO Brush: Brush will NOT be accepted and chipped at curbside. During Spring Clean-up residents may bring their brush to Lisbon's Public Works Garage at 486 River Road (Route 12) from 7 am to 1 pm, Monday – Friday. To inquire about obtaining wood chips from the highway dept call (860) 204-0355.
