Burnham Highway - Mr. Hamel's Attorney, Harry Heller, of Heller, Heller & McCoy, 736 Route 32, Uncasville was present to speak on behalf of Mr. Hamel, and stated that the Statutory Procedure that requires an appraiser be chosen before a Fee-In Lieu of Open Space is determined, was totally ignored at the time. Mrs. Sperry noted that the original Subdivision Application was approved 12 years ago and, judging by the meetings transcripts, Mr. Hamel had ultimately agreed to the \$6000.00 per lot and did not contest that amount until recently. Motion by K. Sperry second by C. Blanchard not to entertain the re-opening of the Fee-in-Lieu of Open Space on the Burnham Hill Project as presented by Mr. Hamel.
