- a. ZEO Carl Brown, Zoning Enforcement Officer, was present and gave a brief update regarding the Cease and Desist Order for Lowe's. Mr. Murphy noted that Lowe's Corporate is being cooperative and that an application and new site plan is likely to be submitted before the February meeting.
- b. Regulations NONE
 - 1. MS4 Storm Water Regulation/Ordinance Update Mr. Murphy gave a brief update and outlined the most significant sections of the ordinance. It was noted for the record that the draft ordinance was sent to the Commission members in their packets, and that the information was up on the Town website for public review. He also noted that the Conservation Commission is best suited as the governing agent. Mr. Danburg questioned the payment of fines and the definition for the Conservation Commission; Mr. Lebel had concerns about the language for fines. Mr. Hull stated that a fine (citations) ordinance had once been rejected by the residents. He also questioned enforcement, and asked for definition of "State Waters", being concerned for owners of private property to which Mr. Murphy gave some clarification. Mr. Sparkman reminded Mr. Hull and the rest of the Commission that this ordinance is mandated by the State and that we have no choice but to implement an MS4 Storm Water ordinance. He also cited various instances in Town where water courses had been affected by pollutants coming from storm drains, and that this does occur in town.

Mrs. Sperry also noted that she advocates for the sidewalks for the sake of safety as well as being good for business in that area. Mr. Giroux questioned Mr. Sparkman about access to the Dam at the Boat Launch area. Mr. Sparkman replied that the location is controlled by Wheelabrator and he will get in touch with them.
