Mr. Murphy noted that the draft regulations for sections 4 and 10.2 have been added to the website for review by the Commission and the public and can be found under the corresponding agenda of June 2, 2020.


- a. Regional Planning Commission – NONE
- b. Sigfridson Subdivision/Resubdivision, Fitch Road – Extension Under Executive Order 71 to Open Public Hearing August 4, 2020 – Mr. Murphy noted for the record that he had mailed Staff comments to the applicant on June 1, 2020. He reminded the Commission that the applicant had already granted consent for a 65-day extension to his application that was received on March 3, 2020, bringing a deadline for action to July 11. Executive Order 71 allows for an additional 90-day extension at the discretion of the commission or applicant. Mr. Murphy also noted for the record that the application and supporting documents are available online, under the corresponding agenda of June 2, 2020, for review by the Commission and the public. Motion by T. Danburg second by J. Lebel to grant a 24-day extension to allow for the Public Hearing to be opened on August 4, 2020, under the Governor's Executive Order 71.

- c. Bylaws – Review and Discussion of Proposed Revisions – Mrs. Sperry recommends that the Commission now forward the draft to the Town Attorney for review and advisement. The sub-committee questions whether or not a Commission alternate be appointed to sub committees. The planner will coordinate with commissioner Sperry to refer the draft and questions to the Town Attorney.

 - i. Zoning Board of Appeals – 5 Sylvandale Road, Robert Roarke, Applicant – for Variance of Section 8.5 (Rear Setback Requirements) – Mr. Murphy noted for the record that his Staff report was forwarded to Mr. Roarke, the ZEO and to the Commission. Motion by K. Sperry second by J. Lebel to have Mr. Murphy’s Staff Report forwarded to the Zoning Board of Appeals to be read into the record at their Public Hearing scheduled for June 23, 2020.  - ii. Town of Sprague – Sprague Planning and Zoning Commission, Applicant – Addition of New Section (Section 22) to the Sprague Zoning Regulations – Motion by T. Danburg second by K. Sperry to send a letter of no intermunicipal impact. VOTE: UNANIMOUS, MOTION CARRIED
 - c. Staff Update Regarding Revisions to Applications – Mr. Murphy noted for the record that any supplemental fees received by applicants will go directly to the Clerk to the Boards, then will be deposited with the Treasurer. Mr. Murphy also noted that Executive Order 7MM allows for expedited municipal zoning amendments in order to quickly and safely respond to COVID19. He has updated zoning and subdivision applications that will be utilized by the public, including a temporary COVID-19 permit (outdoor seating), which are now on the website.
8. Any other business which may properly come before the commission – Mr. Giroux noted for the record that the Lowe’s parking lot is a disaster with outside sales on weekends. The Zoning Enforcement Officer is to be notified.
9. Public Comment – It was noted for the record that no Public Comments were received by email as directed on the Town’s website.
