He noted that of 27 Cease and Desist orders, 6 are working with him to resolve the issue and 11 have complied and are correcting the issues. Mr. Brown and Mr. Murphy noted that they both contacted the Town of Sprague regarding 70 Inland Road (Papermill Road) but the situation remains unresolved. Mr. Murphy read the response from the ZEO and Blight Officer, Joe Smith from Sprague who indicated that he could not identify it as blight.

It will then go the Board of Selectmen for consideration of the ordinance at Town Meeting.

Sigfridson Subdivision/Resubdivision, Fitch Road Discussion Mr. Murphy gave a brief update and talked about the alternatives available to the Commission, since Mr. Sigfridson did not complete the subdivision and has withdrawn his most recent application to address outstanding issues. Based on the opinion from the Town Attorney, the Commission could take action to expire the subdivision. If the Commission pursues this process, it should have an administrative hearing for the benefit of the applicant. If the Commission expires the subdivision, discontinuance of the proposed Fitch Road would require action on the part of the Board of Selectmen at Town Meeting. Motion by K. Sperry second by T. Minor to schedule an Administrative Due Process Hearing at the September 1, 2020 meeting under "Old Business" to consider expiring the Sigfridson Subdivision at Phillips Road and proposed Fitch Road.
