- 2. Discussion of Affordable Housing Plan Survey Ms. Carly Holzschuh, AICP of the Southeastern Connecticut Council of Governments, was present. She stated that a total of 207 survey responses were received. She presented the Commission with copies of a PowerPoint presentation highlighting the survey results and recommended considerations for the Plan. The Commission requested that Ms. Holzschu leave out items that do not ultimately affect the Town's numbers with the State's 8-30g requirement, such as the expansion of support for elderly/disabled tax relief programs and tax rebate programs for first time homebuyers. Ms. Holzschu stated she will have a draft Affordable Housing Plan for the May 3 meeting.
