Ritacco that the planning and zoning commission adopts the following policy: Whenever an appeal is taken to the superior court from the commission's approval of an application or permit, the commission's lawyer may notify the applicant or permit recipient or their attorney that the applicant or permit recipient shall have the primary responsibility for defending the appeal, meaning that applicant or permit recipient shall have the responsibility of preparing a draft appeal brief for the commission's attorney's review. If the applicant or permit recipient does not provide a draft brief for the commission's attorney's review in such cases, the commission's attorney may notify the court that the commission will not defend the appeal.
