 - i. Town of Preston Zoning Amendments #2019-01, Comprehensive Revisions to the Preston Zoning Regulations including revisions to the Zoning Maps The planner noted no apparent inter-municipal impacts from the proposed revisions since no zoning changes affected the border with Lisbon.
- c. Sunfox Campground David Nowakowski, 15 Kenyon Road Request for informal and non-binding discussion to obtain preliminary feedback regarding possible modifications to campground Mr. Murphy explained the history leading up to this pre application request and that he recommends no decisions or detailed analysis take place tonight. Mr. Nowakowski made a brief presentation regarding possible plans for modifications at the campground. He requested input from the commission regarding the interpretation and application of internal road and emergency access provisions in campgrounds before he undertakes detailed application preparation to expand the campground. After a brief discussion, the commission consensus was that the intent of these access provisions was to permit some flexibility in the total number of access points in campgrounds of more than 50 sites, provided a principal access roadway and emergency access way constitute two access points for public safety. Mr. Nowakowski thanked the commission for their input.
