2. Reading of Previous Minutes - Motion by N. Smigiel second by L. Sylvestre to waive reading of previous Regular Meeting minutes of 4/15/19 and Special Meeting minutes of 5/8/19 and approve the minutes as mailed. VOTE: UNANIMOUS, MOTION CARRIED
