K. Magness respectfully asked the commission to consider allowing the Lisbon Farmers' Market to be held in the area adjacent to the community barn at Lisbon Meadows Park. Ken Washburn stated he would advise the town Selectmen and the Fall Festival Committee of this plan.
 - b. Don Potts of the Lisbon Men's Basketball turned in money collected. He stated he would like to get Men's Basketball back to allowing just Lisbon residents. J. DiRoma stated he agreed, and that out-of-town players should be charged higher fees until the switchover is accomplished. T. Restivo recommended the switch take effect after the winter break.
 - c. Matt Torocchi of the Eagles was present to say "thank you" for allowing him to put up a sign for the Veterans on Veterans Day, and for allowing him to put flags on the gravestones of Veterans at Ames Cemetery.
 - d. Mr. Albert (Mario) Tulli was present to fill the vacant spot left by Miles Lafemina.
