2011 Egg Hunt Final Report

The 2011 Egg Hunt went well with no real issues to report. The weather was not an issue for the first time in three years!! The children of Lisbon "hunted" the eggs in record time, with the park being clear--of all people-- by 10:20am the latest. There was a great turnout this year--the majority being in the 2-4 age group with about 35-40 participants. The 5-7 year old group was not far behind in numbers with approximately 25-30 participants. The 8-10 age group had the least number--around 10 participants-- but some parents brought there younger child from the 5-7 group over to the 8-10 so they could be together. Altogether, there were approximately 80 participants in this year's hunt.

The total cost for supplies was \$580.02. The breakdown is as follows:

Candy: \$450

Plastic Eggs, 11 boxes: \$110

Misc. Supplies, buckets, grass, etc: \$10

Tax: \$10

There was a bit of savings this year with the costs. I recycled the signs that I made last year and re-used the poles used to "gate-off" the 2-4 year olds. In past years, I would purchase 2 cases of the eggs at a cost of about \$110 per case (with 1000+ eggs in each case) This year, Walmart offered boxes of 220 plastic eggs for \$10 each. I purchased 11 boxes of these eggs, totaling 2420 eggs, for only \$110. There were some quality issues with some of the eggs in the boxes, but not any more than in past years. Also, more eggs seemed to stay closed, making it easier to put them out on the day of the hunt. The only issue with the purchasing of the supplies is that the town no longer has a credit card for Walmart, or any other store. The cost was out of pocket for me, which was fine except that I did not know this until the day I was going shopping for the supplies. I had to detour to the bank and make sure I had enough cash and/or credit on me for the purchases.

Overall, this year's hunt was successful. Some suggestions/comments for next year:

- The 4 year olds monopolize their age division...perhaps a new age division...4-6, then 7-10 and let the 2 and 3 year olds take their time. (I will need new signs!!)
- The egg-stuffing went as well as can be expected. However, due to the number of eggs needing to be stuffed and the amount of time needed to complete this task, the town girl scouts and/or boy scouts may be called upon next year for community service work!!
- Payment for the supplies...can we get a check from the town to purchase items?
