1. Call to Order - The regular meeting of the Recreation Committee was called to order by Chris Fabry, Interim Vice-Chairman, at 7:09 pm.

2. Reading of Previous Minutes - Motion by C. Fabry second by A. Lagace to waive reading of previous Regular Meeting minutes of 9/20/21 and approve the minutes as mailed.

5. Old Business

- a. LMP
 - i. Bleachers and Picnic Tables – Review and discussion. Mr. Fabry will check on their condition as they remain outdoor all year long.
- b. Fall and Winter Programs
 - i. Program Plans and Fee Collections – Mr. Rhoades, co-ed volleyball league coordinator, reported that he approached the Town about setting up a VENMO account for payments with an electronic ledger to keep track of all payments, but was told that is not an option at this time. Cash Payments will continue, and hand-written receipts given out. The co-ed volleyball league will begin December 2nd with no spectators. All COVID-19 protocols will be followed. Contact tracing will be administered. Masks or gaiters must be worn at all times. Anyone under the age of 18 participating will need to be accompanied by a guardian. Mr. Fabry reported that Nancy Smigiel will not be running the women's volleyball league this year. There is a possibility of one night a week as pick-up games.
- c. Committee Calendar – Mr. Fabry went over what was on the calendar for November – draft a budget (Vice-Chairman Restivo will be working on it), closing up of the fields, taking in the tennis nets, soccer nets and batting cages for the winter. Mr. Fabry suggested leaving up the tennis nets until the middle of December and also leaving up the soccer nets for the time being because they are still being used. Two port-a-potties will remain at the Lisbon Meadows Park, but the rest will be removed for the winter months. Discussion of possible ideas for 2022 bus trips include Red Sox game, New York City musical, New England Patriots game, and the Big E.

- b. FY 2022-2023 Budget Submissions – Mr. Fabry asked Program Directors to send projected costs to Vice-Chairman Restivo. It will be voted on at the December meeting for submission to the Board of Selectmen in January.
- c. Wrestling Program – Dave Nowakowski, Owner of Sunfox Campground, was present. He reported to the Committee that he has spoken to Thomas Sparkman, First Selectman, regarding holding a beginner wrestling clinic for Grades 3 – 8 for boys and girls. First Selectman Sparkman will add the wrestling program on the next Board of Selectman agenda to be discussed with possible vote. Mr. Nowakowski plans to have one group of 24 students from grades 3, 4 and 5 and another group of 24 students from grades 6, 7 and 8. The cost will be \$20 for Lisbon students and pending availability, he will open it up to other towns at the cost of \$30 per student. It will be held at the Recreation Hall at Sunfox Campgrounds. Program will be starting soon with sign-ups mid-November. Motion by A. Lagace second by M. Sikorsky to nominate Dave Nowakowski as the director of the youth wrestling program for the 2021-2022 season.


