2. Reading of previous minutes – Motion made by R. Rhoades second by K. Gleason to accept the previous Regular Meeting minutes of August 15, 2022 as presented.

6. New Business

a. Pickelball program – S. Berger spoke about the sport of Pickleball, equipment used and different court options (see attached). The committee discussed adding Pickleball to the sport options for the town. This would entail outfitting the tennis court at Lisbon Meadows Park for two Pickleball courts as well as the two gyms at the Lisbon Central School with markings and nets. The court time at the Lisbon Central School would be open session play on Monday and possibly Wednesday evenings from 8-10 p.m. if approved by the school. Mr. Berger volunteered to coordinate the program but will be looking for an assistant to help with this. Motion made by A. Lagace second by K. Gleason to fund up to \$2000.00 for indoor/outdoor Pickleball supplies.

 - a. LMP Soccer Field R. Rhoades reported that the soccer field is back open. The Lisbon Central School now has a soccer team that is using this field. The lines on the field need to be repainted. Motion made by R. Rhoades second by A. Lagace to approve up to \$250.00 for the field to be striped.

R. Rhoades would like to work with volunteers from the school to clean up and spread wood chips on the cross country trails. The town garage does not have enough in stock for this so another source will need to be found. R. Rhoades will research.

Pickleball Court Options

Option 1 - \$30 (paint)

Superimpose 1 pickleball court on the existing Lisbon Meadows Tennis Court.

Pros – Very inexpensive, adds a few different color lines to the tennis playing area. Utilizes the existing tennis net.

Cons – You only have one pickleball court, limiting you to 4 players at a time.



Option 2 - \$500 (portable nets, storage, and paint)

Superimpose 2 pickleball courts, with one on either side of the existing tennis court net. This is what was done on two tennis courts in Leary Park, Waterford, CT resulting in 4 pickleball courts.

Pros – still relatively inexpensive. You get two pickleball courts on the existing tennis court, allowing for 8 players at a time. This method is used for very high level pickleball at tennis facilities that host professional tournaments.

Cons – Adds a few more lines to the tennis playing area. Requires the purchase of portable pickleball nets that have to be stored or secured to prevent theft.



Option 3 - \$650-\$850 (tape or paint and portable nets)

Use paint or semi-permanent tape to place pickleball court lines on the LCS gym floor.

Pros – Inexpensive, there is room for 3-4 pickleball courts on the basketball playing area. Allows for year round evening play, heated and air conditioned.

Cons – Requires purchase of portable nets, but storage much easier at the school. Theft/vandalism probably not an issue.




Option 4 - ALL IN \$40,000-\$60,000 per court depending on options.

Build courts. This is almost what has been done in Colchester (3 courts) and Windham (6 courts), and several other CT coastal towns. They had existing "pads" but added fencing, lights, windscreens, and surface paint.

Pros – as many beautiful permanent, dedicated pickleball courts as you want. There is plenty of relatively level ground in Lisbon Meadows.
