To the electors those qualified to vote at a Special Town Meeting of the Town of Lisbon, Connecticut, warning is hereby given that a Special Town Meeting will be held on Wednesday, August 11, 2021 at 7:00 p.m. in the **Lisbon Town Hall Conference Room, 1 Newent Road, Lisbon, Connecticut for the following purposes:**

1. To discuss and act upon a resolution authorizing (a) an appropriation of \$250,000 from available funds in the general fund to pay a portion of the costs a fire engine tanker truck and related equipment (the "Project") and undertaking by the Town of a lease-purchase financing with PNC Equipment Finance in an aggregate principal amount not to exceed \$710,000 and with an amortization not to exceed five (5) years, to fund the balance of the costs of Project.
2. To authorize the Board of Selectmen as authorized by the Board of Finance, to transfer \$54,605.00 from the CNR account designated Capital Projects to pay for the Senior Center window replacement project.

A copy of said resolution, the Tax Exempt Lease Purchase and Fire Engine Tanker Truck information is on file and available for public inspection at the Office of the Lisbon Town Clerk.

I FURTHER CERTIFY that all of the above acts were done at least five days before the holding of said meeting on August 11, 2021.


