The amendment to section 4.1.3 under section 4 <u>Permitted Uses</u> in the residential zones will address the jurisdictional issue of regulation of forest practices as prescribed by statute, which delegates regulatory power to the inland wetlands agency. The amendment to section 11.5.3 under section 11 <u>Special Permits</u> will address the recent statutory changes regarding additional notifications to abutters in the case of special permit applications.
