- a. Autozone update Chairman Robb reported that Autozone was ready to connect to the main line but covered their pipe work before it could be inspected and approved. He is working with Autozone and Towne Engineering to resolve this issue.
- b. ARPA project updates
  - i. Pump station updates Chairman Robb reported that this project is in the planning stages and will take an estimated 6-10 months to complete.
  - ii. Sewer line inspection update Chairman Robb reported that this project is in the exploratory planning stages.
  - iii. Add seals on the manhole covers to prevent water from getting into the sewer system. Chariman Robb has been in contact with Norwich Public Utilities who can provide the necessary seals. He will measure the covers to determine the correct sizes to order.
  - iv. Water meter installations at Versailles Chairman Robb has been in contact with Sprague Water & Sewer for more research into this project.
- c. Update on sewer billing procedures Chairman Robb reported that he has spoken with JCU-Water about taking this on. They are currently researching how to provide the necessary usage reports.

- a. 2023 Meeting Calendar The committee would like to change the meeting day for 2023 to Wednesday instead of Thursday. If the Town Hall is not available on those days, the meeting may be able to be held in the Lisbon Senior Center. (see attached).
