- Old Business
 - a. Application Janice Abrahamson 405 South Burnham Highway Application #14-03. L. MacDonald made note that the applicant was not present at the public hearing. He also stated that they could not give a variance on something that is strictly prohibited by the town's regualtions. Chairman R. Babbitt mentioned his concern for the Americans with Disabilities Act. Atty. Kari Olson stated that the use of the camper as a permanent dwelling is strictly prohibited under the Town's regulations and they cannot give a variance to it. She also stated that there is no legal hardship with the property itself, and no multiple, single-family dwellings are permitted in that zone. She stated there is no basis for legal hardship that would stand under judicial scrutiny. There is also concern with the Health Department how would waste be managed? The Commission does not have authority to grant a temporary variance. There is no legal hardship under state law.

Motion was made by L. MacDonald second by R. Jencks to not allow for the variance.

<u>VOTE:</u> R. Jencks – deny variance, Attorney advises we do not have the authority to allow it;

- S. Beck deny variance, based on the regulations and the way the application was written;
- F. Kral deny variance, section 16, Zoning Board of Appeals, and variance 16.1.2, last line says "no use variance shall be granted which would permit a use prohibited by these regulations".
- L. MacDonald deny variance, based on regulation 16.1.2, they are not allowed to give a variance to a prohibited regulation.

Chairman Babbitt – deny variance, because there are too many regulations against having it.
